1 INTRODUCTION

As an international company operating in many regions of the world, Thinkproject Group is affected by local, national and international laws, regulations and public policies. It is our objective to maintain legally irreproachable relations with governmental bodies, as we act transparently, honestly and in compliance with the applicable law and the principles outlined in our Code of Conduct.

This policy describes the guiding principles for political engagement and all forms of political activity by Thinkproject Group and our employees. We want to ensure that our employees understand the importance of the guidelines set forth in this policy and act in accordance with these commitments.

2 **COMMITMENT**

Thinkproject Group is committed to act in compliance with all applicable regulations and moral standards regarding the political engagement of organisations. As a company that has defined integrity as one of its core values, we do not engage in any action resulting in undue influence or unfair competition. This includes our commitment not to make political contributions, donations or lobbying expenditures. To enforce this commitment, Thinkproject Group has an internal approval process to ensure that donations, sponsorships or gifts are not politically motivated. This approval process is conducted on a case-by-case basis, with approval required by the Thinkproject Group CEO or CFO.

Should Thinkproject Group change this policy to allow political donations and/or lobbying expenditures in the future, Thinkproject Group commits to disclose the payments made and follow all applicable laws and regulations.

3 PERSONAL POLITICAL ACTIVITY AND CONTRIBUTIONS

We encourage our employees to be active in civic and community activities, including participation in the democratic and political process. At the same time, we want our employees to be aware of the following guidelines:

- Political involvement should take place outside of employees' working hours
- Political contributions are not reimbursed by Thinkproject Group
- All forms of political activity or contribution must comply with applicable laws and the Thinkproject Group Code of Conduct.
 All employees must consult with the Legal Department or the Compliance Department when in doubt
- Political involvement of any kind on the company's behalf is prohibited: if employees are engaged in political activities, they
 must make sure not to create the impression that such activity is associated with or on behalf of Thinkproject Group
